**INSTRUCTIONS FOR USE**

Industrial production line machines: run the pump with undiluted **RMC Biocleaner**, until the deposits clogging it have been completely cleared. Rinse in clean water before resuming production.

Manual equipment: soak the equipment (brush, paintbrush) in undiluted **RMC Biocleaner** until all grease has been removed. Rinse in clean water before re-using equipment.

Clothing and shoes: rub the fresh stain gently with a cloth soaked in **RMC Biocleaner**. Where the garment is spattered with stains, wash in the washing machine on a 40° minimum cycle; with 200 ml of the product.


